# **CDC Interns: List of Responsibilities**

<u>Timeline:</u> We would like to begin the onboarding process by the end of June/early July 2022. Interns would be expected to work with us until next May/June 2023.

<u>Time Commitment</u>: Interns are expected to attend the clinic nights on Wednesdays from 5:30-8:30pm (usual arrival is expected around 5/5:15pm and sometimes we stay to clean up/break down until 8:45/9pm), in addition to doing some work outside of the clinic (i.e. remotely) on projects specific to your role. While some responsibilities are remote, interns should be local in order to attend in-person clinic nights on Wednesdays.

For the last couple of years, CDC has not been processing the collected data from our patients-this makes it somewhat difficult to show our progress and measure our impact. We'll go through with you the kind of data that can be pulled out of the Axium software and from there, we can make a plan as to what we'd like to measure. We'd like to total up the amount of treatment done, the number of patients we've seen, and display in a report the impact we've had. We would like to continually update the list of which centers patients are coming from. One project we would like to pursue is to monitor our production and treatments in Prosthodontics cases this past year that have been funded by an ADA Foundation Grant and compare to previous production. Later, this will be presented to the donors responsible for paying for all of their care. Lastly, the research intern will be supporting the patient intern to administer the patient satisfaction survey.
